#### Report from CNCF Director, Associate Professor Craig Lockwood

The end of 2017 bulletin is an illustration of the business of Cochrane Nursing Care. Over the year, many of our members have been active contributors to one or more of our knowledge translation (KT) programs, and many have become published authors, or extended their CV by adding CNCF publications to their professional activities. Firstly, I want to recognise that the success of our KT programs is very much a direct result of the work Alex Mignone puts in each week as the Program Coordinator. Secondly, our authors, the Journal Editors and Editors-in-Chief who continue to support the dissemination of Cochrane evidence deserve recognition. The diversity of journals, their distribution, geographic and representation impressive, no other Cochrane Field has such a large and diverse portfolio of journals involved in a KT strategy. Cochrane's Structure and Function review has completed, and the next phase is beginning. That is to undertake an internal Field evaluation of activity, and develop a strategic plan to 2020 which embeds the Cochrane Knowledge Translation Strategic Plan. This is the major piece of work that Alex and I will be taking forward in the first half of 2018, and as the strategic goals are clarified then ratified by the Cochrane Central Executive, we will be sharing those with you, and asking for groups and individuals to volunteer to contribute. Much is changing in Cochrane, the new membership scheme is a major change, and will open doors for nurses to collaborate on a wider range of activities and evidence projects than has been possible before! While working with the Cochrane central executive on strategic planning, Alex and I have also been working with the Fields executive by leading on a research project Corners. related to Cochrane Most Cochrane Fields either have or are planning to implement Cochrane Corner programs as part of their KT strategy, and it is a major KT program for us in Cochrane Nursing. However, very little (until now) has been known about best practice in relation to resourcing, development, management and the kinds of tools, templates and resources that ensure a diverse authorship group can maintain high quality standards for these key publications. Our project involved collecting process based guidance from each Field, then undertakina analysis a content and mapping exercise to identify the commonalities and differences across Fields. Phase two has been to conduct a series of one to one interviews with Fields Executive Staff (this phase is ongoing), and the final phase is to complete the analysis write а paper recommending minimum criteria for resourcing a high quality Cochrane Corner program as a knowledge Translation activity. It is great to

see nursing leading the process evaluations on KT strategies; with the development of our strategic plan, and the consultation that will be occurring with you, the members, there will be additional opportunities to become involved in evaluation studies, core operations and leadership within the Nursing Care Field. We look forward to bringing those opportunities to you in 2018, and in the meantime hope that as you reflect on 2017, that you find the good, the productive, the positive, and focus on these while enjoying the festive season - no matter what your schedule, roster or shift rotation looks like for that last week of December.

## Journal for Research in Nursing & Health to join the CNCF evidence dissemination mission in 2018



The CNCF continues to widen its reach in dissemination of Cochrane practice evidence, and it is pleased to report on another high impact international journal joining its mission. The Journal for Research in Nursing and Health has recognised the valuable work the CNCF is doing in getting best evidence into practice and has agreed to publish the Field's Cochrane review summaries, entering an initial arrangement for the regular publication of a 'Cochrane Corner' column. This is an exciting new undertaking



for the Field that will see its Cochrane review summaries feature in this highly regarded international journal throughout 2018.

With an impact rating of 1.693, the Journal for Research in Nursing and Health is a general peer-reviewed research periodical devoted to publication of a wide range of research and theory that informs the practice of nursing and other health disciplines. The journal invites research reports on nursing practice education, administration and history, on health issues relevant to nursing and on the testing of research findings in practice.

On its newly established collaboration with the CNCF, the Editor-in-Chief for the Journal, Professor Margaret Kearney, writes: 'Research in Nursing and Health reports research that adds significantly to the global literature on health, illness, and health care delivery. Cochrane Reviews are the premier source of rigorous and timely reviews of that literature. The CNCF's concise summaries of Cochrane reviews on topics important to our readers will illuminate current evidence and reveal important next steps for research in nursing and health science'

#### CNCF 'Writer in Focus' series: Associate Professor Robin Christian

This values the opportunity group acknowledge the efforts of these extremely busy people who are prepared to take time out of their schedules and prepare summaries on Cochrane reviews for publication because they believe the work is of great value in bringing best practice to patients. Through the work of the Field's volunteers, the subscribers of these journals are getting the opportunity to access highly relevant Cochrane evidence that they can take back to their workplace and influence the way nurses and related healthcare professionals administer support at the bedside. In this final edition of our CNCF bulletin for 2017, we acknowledge and profile someone who has been a regular contributor to the Field's publication work for over two years; Associate Professor Robin Christian.

Robin Christian has over 23 years' experience as a Registered Nurse, and 18 years as a Family Nurse Practitioner. She is currently an Associate Professor of Nursing at the University of Mississippi Medical Centre (UMMC) School of Nursing (SON) in Jackson, Mississippi, USA.

Robin is an accredited trainer and reviewer for the Joanna Briggs Institute (JBI) Comprehensive Systematic Review Training Program, Adelaide, Australia. She is the creator and convener of the UMMC SON: An Affiliated Centre of JBI. On the work of the UMMC SON, Robin writes: 'The team is responsible for teachina the methodologies of systematic reviews to faculty, students and community partners. The Research Team is also responsible for scholarly output, focusing on evidence synthesis, to support the global mission of JBI.' Robin was also instrumental in creating a unique partnership between a Health Quality Organisation and the UMMC SON. The School of Nursing is collaborating with



Information and Quality Healthcare (IQH), creating an annual IQH Fellowship program. Nursing home staff and administrators are selected from an application process to become a Fellow. Fellows then work with SON faculty for one year, in creating and implementing a quality improvement project in a long term care facility.

In addition to her many functions, Robin is also the project manager for a three year, \$2.1 million dollar, HRSA grant. The grant project, Integrated Behavioural Health Program, developed a nursing education program in collaboration with interprofessional teams to provide integrated behavioural health care with telehealth capacity to individuals with multiple chronic conditions.

Robin's passion goal her and for professional activities is the elimination of health disparities through nursing innovation. She is an active member of professional organisations, several including the CNCF.

On her experiences preparing summaries for the CNCF, Robin writes: 'I enjoy writing summaries for the CNCF because it's so important to disseminate evidenced based findings from systematic reviews so as to improve practice and policy. Summaries of findings from Cochrane systematic reviews give busy clinicians access to concise, up to date recommendations, and these articles are of particular benefit to nurses because of their focus on the potential benefits to practice.'

Writing summaries for the Field has also allowed Robin to practice and refine her skills in reading, writing, and interpreting systematic reviews. She is grateful for the CNCF and the journals that publish the Field's summaries on Cochrane review

evidence, and encourages others to get involved and support the work.

## Another valued contributor to the Field's summary production work; Professor JoAnn Long

A contributing member of the CNCF for some time now, we are privileged to acknowledge the work of Professor JoAnn Long in the development of high quality Cochrane review summaries.

Despite her demanding role as Professor of Nursing and Director of Research and Development at Lubbock Christian University (LCU), JoAnn still finds the time to prepare summaries on Cochrane reviews for the CNCF because of how vital she believes the activity is in getting valuable evidence to nurses and healthcare professionals, and in turn to patients and their families.

JoAnn has served as a faculty member of the Lubbock Christian University for over 24 years, teaching the Registered Nursing (RN) program, Bachelor of Science in Nursing (BSN), Master of Science in Nursing (MSN), and Family Nurse Practitioner program, in addition to coordinating governance of LCU's Department of Nursing. As a professional nurse, she has practiced nursing in acute and long-term care, and has served in both school and home healthcare settings. Her work with students has focused especially research at both the graduate and undergraduate levels, mentoring front-line registered nurses at developing projects for poster and paper presentations at local and international scholarly conferences.

On her reasons for joining the CNCF's mission, JoAnn writes: 'Bringing good evidence to the frontline of patient care, the CNCF is an invaluable resource for nurses because it provides them a resource and knowledge base they may not otherwise have access to. The work of the Field has the potential to significantly

impact the way nurses internationally treat patients in their care.'

In addition to her many professional achievements. JoAnn was also recipient of the 'Outstanding Faculty Mentor Award' granted by LCU's Council on Undergraduate Research, to recognise her ongoing efforts to coordinate with the Nursing faculty in guiding and encouraging JoAnn believes the student research. resources produced by the CNCF provide healthcare workers the latest evidence where it is needed the most: at the point of care. JoAnn's own research has been in area of health promotion adolescents (diabetes and chronic disease prevention), in particular, how Functional Magnetic Resonance Imaging (FMRI) and cell phone technology can be used to promote fruit and vegetable consumption in young people. She also has a research focus in the area of evidence-based practice and knowledge synthesis for the purpose of improving clinical care. JoAnn adamantly believes the summaries produced by the CNCF are a tremendous resource for academic faculty engaged in teaching evidence-based practice skills to nurses.

## Cochrane Translations: Making Cochrane podcasts more relevant to a Brazilian audience

The Brazilian translation team have been modifying English language Cochrane podcast scripts before translating them into Portuguese, in order to make them more suitable for their local audience.

The Portuguese translation team at Cochrane Brazil felt that while Cochrane podcasts have the potential to be a great tool for disseminating health evidence, the podcast scripts were too long and too difficult for the average Brazilian listener to understand. When translating from English to Portuguese, the Portuguese text can often end up being up to 30% longer than the original. Therefore, the translation team decided to make tweaks to the scripts before we translated them and recorded the audio files in Portuguese.

So far, this new initiative has seen a substantial rise in views of the Cochrane Translations website, with more than 50% new visitors since July 2017. This would indicate that people are getting familiar with the new page and information, with a significant increase of repeat visitors. Cochrane are still monitoring the statistics, and hope to present more details on impact in 2018.
